1. Agreement Overview: This document outlines the terms and conditions (the "Agreement") by which ______ ("Seller") will sell and the buyer ______ will purchase a puppy. By completing the purchase, the buyer agrees to all terms outlined herein.

3. Purchase Price: The total purchase price for the puppy is \$1,750 payable via Cash App, Venmo, Cash, Zelle, or PayPal.

4. Deposit: A non-refundable deposit of \$600 is required to hold a selected puppy. The remaining balance must be paid within two weeks of initial payment. A puppy may be selected after the puppy has reached 5 weeks old. If the remaining balance is not paid within two weeks of deposit or by agreed upon date ______, the buyer waives all rights to reserve the puppy. Any deposit made will be non-refundable.

5. Health Guarantee:

The Seller guarantees that at the time of sale, the puppy is in good health and free from any known hereditary defects or illnesses. The Seller has no knowledge of any health issues affecting the puppy at the time of sale.

Buyer Acknowledgment:

The buyer acknowledges that they have received and reviewed all relevant health information pertaining to the puppy.

Limitation of Liability:

The Seller makes no warranties or representations regarding the puppy's future health or well-being. After the purchase is completed, the seller assumes no responsibility for the puppy's health or behavior, and the buyer acknowledges that they are accepting the puppy "as is."

No Refunds or Exchanges:

The Seller will not provide any refunds, exchanges, or additional guarantees related to the puppy's health after the completion of the sale

Acceptance of Terms:

By signing below, the Buyer acknowledges that they have read, understood, and agree to the terms of this Health Guarantee.

6. Return Policy: The Buyer has the right to return the Puppy within 72 hours if they can no longer care for it. The Puppy must be returned in the same condition it was received. No refund will be issued.

7. Transfer of Ownership: Ownership and responsibility for the Puppy will transfer to the Buyer upon full payment and delivery of the Puppy. The Buyer is responsible for all care, costs, and veterinary expenses for the Puppy once ownership is transferred.

8. Care Requirements: The Buyer agrees to provide appropriate care, including but not limited to:

- Proper nutrition
- Regular veterinary check-ups, vaccinations, and treatments
- Socialization and training
- A safe and loving home environment

9. No Breeding Clause: The Puppy is sold as a pet and cannot be bred without the Seller's prior written consent.

10. Liability Waiver: The Buyer agrees to hold the Seller harmless from any and all claims, damages, or liabilities arising from the ownership or behavior of the Puppy after the transfer of ownership.

11. Governing Law: This Agreement shall be governed by and construed in accordance with the laws of the state of Georgia.

12. Amendments: Any amendments to this Agreement must be made in writing and signed by both parties.
